

# 1. SCOPE OF APPLICATION

1.1 The following conditions of participation apply to the running event "Running Against Cancer" - 2024 (hereinafter referred to as "Event").

1.2 The organizer of the events is the

### 2. REGISTRATION AND PARTICIPATION FEES

2.1 Registration for the events takes place as online registration via our registration mask on our website. On-site registrations may be carried out in exceptional cases.

Registration is possible in German and English. The following information must be provided with the registration:

Name, running category, birthday, telephone number, e-mail address.

2.2 Persons younger than 16 years can only be registered by their legal representatives. Please indicate the name and date of birth of the child.

2.3 The contract is concluded when the organizer sends the confirmation of participation, which will be sent by e-mail after registration. With the registration confirmation, the participant will receive the account details for the transfer of the entry fees and the data entered by him/her during registration. If the participant has to make changes, the organizer has to be contacted by e-mail, so that the organizer can make or note the changes. A subsequent independent change of the data in the registration mask is not possible. All data collected for registration (email, phone number, name and birthday) will be used by the organizer only for the purpose of the event (organization & execution) and will be deleted four weeks after the event.

2.4 The payment of the participation fees shall be made by transferring the respective amount to the account details of the organizer, which will be communicated with the confirmation email of the registration.

2.5 In case of non-attendance, the participant is not entitled to a refund of the participation fees. In case of cancellation of the event, for which the organizer is to be hold responsible, the participation fee will be refunded to the participant.

# **3 PARTICIPATION**

3.1 The participant assures that he/she will only participate on the day of the event if he/she is healthy and in sufficient training condition. If there is or could be a risk of damage to health, the participant will be immediately withdrawn from the race and excluded from the event.

3.2 Each participant will receive his/her race number on the spot upon presentation of the proof of compliance with the hygiene requirements (which are valid at the time of the race) in connection with the presentation of the identity card.

The participant assures that the data provided by him/her are correct and undertakes not to pass on his/her start number and/or timing chip to any other person.

3.3 The instructions of the organizer including his vicarious agents (e.g. medical staff) must be followed at all times.

# 4. PHOTO SHOOTS

Due to the size of the event, it is not possible to delete individual participants from the pictures. A use of the picture recordings is exclusively purpose-related, i.e. in connection with the Run Against Cancer - 2024, if it is reported on or mentioned.

The photos created will be used exclusively in connection with the presentation of the above event, by the organizer on the Internet on the homepage: (https://www.bsio-cancerschool.de/) and the LinkedIn page of the BSIO.

Through the registration, the participant revocably agrees for the future that the photographs taken by him/her in connection with his/her participation will be published for the documentation of the event.

I am aware that photos on the internet can be accessed by any person and that deletion of the photos on the Internet may not be possible.

### 5. LIMITATION OF LIABILITY

The organizer is liable, regardless of the legal reason, only in accordance with the following regulations:

- The organizer is liable in case of intent and gross negligence according to the legal regulations.
- In the case of slight negligence, the organizer shall only be liable in the event of a breach of a material contractual obligation, the fulfillment of which makes the proper execution of the contract possible in the first place and on the observance of which the participant may regularly rely (cardinal obligation). In these cases, the organizer is liable to the amount of the foreseeable, contracttypical damage.
- In the case of slightly negligent conduct, liability for all other damages, in particular consequential damages, so-called indirect damages or lost profits, is excluded.
